**WHEREAS**, the Village of Lawton is applying for \$150,000 in funding through MDOT from the Transportation Economic Development Category B Program to Chip Seal and Fog up to 5 miles of roadway in the Village of Lawton, and

WHEREAS, MDOT requires a formal commitment from the public agency that will be receiving these funds and will be implementing and maintaining these infrastructure projects.

**NOW, THEREFORE, BE IT RESOLVED THAT**, the Village of Lawton will act on their own behalf to request Transportation Economic Development Fund Category B Program funding, act as the agent during the project development, and will sign a project agreement upon receipt of a funding award; and,

**BE IT FURTHER RESOLVED THAT**, the Village attests to the existence of, and commits to, providing at least \$75,000 toward the construction costs of the project(s), and all costs for design, permit fees, administration costs, and cost overruns.

**BE IT FURTHER RESOLVED THAT,** the Village commits to owning operating, funding and implementing a maintenance program over the design life of the facilities constructed with Transportation Economic Development Fund Category B Program funding.
