Fence Permits: There is no charge to get a fence permit. We review the fence placement for height and location. Common mistakes include placing a 6' fence in a front yard (a fence in a front yard can not be over 4') or placing the fence too close to the side-walk for sidewalk maintenance. If the Village is aware of these mistakes, we can help you with a solution before the construction happens.
