A RESOLUTION TO ADOPT NEW ZONING ORDINANCES FOR THE VILLAGE OF LAWTON

At a regular meeting of the Village Council for the Village of Lawton, Michigan, held at the Village Hall in Lawton, Michigan, on the 9th day of July 2024, at 7:00 p.m.

The following Resolution was offered by Councilperson <u>Peterson</u> and supported by Councilperson <u>E. Dudek</u>.

WHEREAS, the Village of Lawton is committed to promoting the health, safety, and general welfare of its residents; and

WHEREAS, the Village Council recognizes the need to update and adopt new zoning ordinances to better reflect the current and future needs of the community; and

WHEREAS, the Planning Commission conducted a Public Hearing, and received input from residents, businesses, and other stakeholders regarding the proposed zoning ordinances; and

WHEREAS, the Planning Commission has reviewed and recommended the adoption of the new zoning ordinances to the Village Council; and

WHEREAS, the Village Council finds that the proposed zoning ordinances are in accordance with the Village's Master Plan and are necessary to regulate land use and development in a manner that is consistent with the best interests of the community.

NOW, THEREFORE, BE IT RESOLVED, by the Village Council of the Village of Lawton, as follows:

- 1. Adoption of New Zoning Ordinances: The Village Council hereby adopts the new zoning ordinances as presented and recommended by the Planning Commission.
- 2. Effective Date: The new zoning ordinances shall become effective on July 25, 2024, in accordance with applicable laws and regulations.
- **3. Publication and Distribution:** The Village Clerk is directed to publish a notice of the adoption of the new zoning ordinances in a newspaper of general circulation within the Village and to make copies of the ordinances available to the public.

- **4. Severability:** If any section, clause, or provision of this resolution is declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the resolution shall not be affected thereby and shall remain in full force and effect.
- **5.** Repeal of Conflicting Ordinances: All resolutions, ordinances, or parts thereof in conflict with the provisions of this resolutions are hereby repealed to the extent of such conflict.
- 6. Record of Proceedings: The Village Clerk shall maintain a record of all proceedings related to the adoption of the new zoning ordinances, including minutes of meetings, public hearings, and all written comments and communications received.

BE IT FURTHER RESOLVED, the Council authorizes Village Manager Todd Hackenberg to sign the application and act as the Village's representative.
